

# CERA Park 2024 Newsletter



## **Park Schedule (2024 Season)**

The park will be open May 3<sup>rd</sup> – September 30<sup>th</sup> (weather dependent)

## **Park Cleanup**

A park cleanup day will be held Saturday, May 4<sup>th</sup> starting at 9 a.m.  
A noon meal will be provided. Please bring your rakes.

## **Forms of Payment**

Credit/debit cards and cash are acceptable forms of payment. (3% fee on credit / debit card charges will be applied) We no longer accept checks for camping, passes, wrist bands and mini golf.

## **Annual Passes**

No Annual Passes will be needed for 2024. However, if you are not camping a car pass will be required to enter the park.

## **Car Camping Pass**

Each Campsite includes 2 car passes for duration of camp stay. Each additional car is \$1 per day, these cars must be parked in the parking lot and not at the campsite.

## **Car Day Pass**

\$5 per car to enter the park for the day for non-campers. \$25 for a season car pass. This pass required for all visiting campers, swimming, fishing, and individuals landing boats.

## **Gatehouse**

Park attendants will be available on a daily basis Monday – Sunday, Memorial Day to Labor Day.

## **Shelter Houses**

The shelter houses will again be available this year for private parties. The large and small shelter houses will both be available seven days a week by reservation only. Reservations may be on the CERA park website at [cerapark.org](http://cerapark.org).

## **Large Shelter House**

May 3<sup>rd</sup> – September 30<sup>th</sup> (weather permitting)  
- Rate \$180.00 reservation fee

## **Small Shelter House**

May 3<sup>rd</sup> – September 30<sup>th</sup> (weather permitting)  
- Rate \$80.00 reservation fee

**Note:** A cleaning fee will be charged if the shelter is not cleaned by the user after use.

## **Swimming Pool & Miniature Golf**

The pools and miniature golf will open Memorial Day to Labor Day. (Weather permitting)

Wrist bands are required for pool use. \$3.00 per person/day 5 years and older. (No longer included with camping fee for 2024 season.)

**\*\*\* When special hours are required, a notice will be posted at the pool and gatehouse. Weather conditions and other circumstances could cause pool closure.**

**Note:** *The only diapers allowed in the pool are those made for swimming use.* Limited supplies are available for purchase.

Miniature golf price is \$3.00.

## **Camping Reservations**

Reservations can be made online at the campground website at [cerapark.org](http://cerapark.org). The weekends of Memorial Day, Labor Day and the Fourth of July are available to everyone for the 2024 season.

Online Self-registration will be used from June 3<sup>rd</sup> through May 23<sup>rd</sup> and then again from September 3<sup>rd</sup> through September 30<sup>th</sup> (weather permitting).

May 3 <sup>rd</sup> – September 30 <sup>th</sup> premium site (1 unit per site) (Sites 18 20 21 22 23 25 27 29 31 33 35 37)	\$50.00 per night
Wilderness camping	\$20.00 per night
Guest tent fee	\$8.00 per night
